- **I. Amend Wapella Water Rate Ordinance 2015-08-18 -** Trustee Falk suggested an increase in water rates to help cover the cost of chemicals for the pump house. The cost of chemicals continues to rise and the village is loosing money. Trustee Falk would like to increase all water rates at 20% across the board. The new prices for water would be:

Residential premises/customers minimum rate - for first 2,000 gallon - \$12.60 Residential customer rate over 2,000 gallon (per thousand gallon) - \$4.28 Commercial premises/customers minimum rate - for first 2,000 gallon - \$27.90 Commercial customer rate over 2,000 gallon (per thousand gallon) - \$10.32
